The Anti-ragging committee, Anti-ragging Squads, Mentoring and Monitoring Cell jointly decide the punishment and inform the Principal in writing for implementation.

Punishments: Depending upon the nature and gravity of the offence as established by the Anti-Ragging Committee of the College, the possible punishments for those found guilty of ragging at the college level shall be any one or any combination of the following:

Cancellation of admission.

- Suspension from attending classes.
- Suspension/expulsion from the hostel.
- Withholding/withdrawing scholarship and other benefits.
- Debarring from appearing in any test/examination or other evaluation process.
- Debarring from representing the university in any regional, national or international meet, tournament, youth festival etc.,
- Handing over to the police for taking necessary action as per IPC.
- Collective punishment: When the persons committing or abetting the crime or ragging are not identified, the college shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggers.
- Any other form of punishment, if suggested.

Note: As per the instruction, each of the student of the Institute and his / her parents/guardians are hereby required to submit an Affidavit at the time of registration/admission, which is mandatory for admission.
