Satish Kumar, Principal**, delivered a PowerPoint presentation outlining the agenda items for discussion.

The following agenda items were discussed, and resolutions were passed:

- Item 6.1 To Confirm the Minutes and review the Action taken report of the fifth Governing Body Meeting held on 19.10.2024.

The Minutes of the Fifth Governing Body Meeting held on 19<sup>th</sup> October 2024 was placed before the Members for reconfirmation. All the members of the Governing Body reconfirmed the Minutes without any modifications and **approved**.

The Action Taken Report on the resolutions passed in the previous meeting was subsequently presented and reviewed. The Members expressed satisfaction with the actions implemented and appreciated the timely execution of the decisions as in **Annexure: I**.

In this regard, it is resolved to authorize the Secretary and Correspondent to approve such expenses and keep the matter for ratification in the next Governing Body Meeting.

Item 6.4

To consider and approve the introduction of a new undergraduate degree programme, B.E. Computer Science and Engineering (Artificial Intelligence and Machine Learning), commencing from the academic year 2025–2026, with an initial intake of 60 students. The proposed intake is to be accommodated by reducing the approved intake of the B.E. Medical Electronics programme from 120 to 60 students, as per the necessary approvals obtained.

The Governing Body deliberated to introduce the B.E. Computer Science and Engineering (Artificial Intelligence and Machine Learning) programme in view of the growing demand for emerging technologies. It was noted that the intake of 60 students for the new programme would be adjusted by reducing the approved intake of the *B.E. Medical Electronics* programme from 120 to 60 students, in line with the statutory and regulatory approvals already secured.

After careful consideration, the Governing Body **resolved to approve the introduction of the new B.E. Computer Science and Engineering (Artificial Intelligence and Machine Learning) programme** with an intake of 60 students, effective from the academic year 2025–2026, along with the reduction in intake for the *B.E. Medical Electronics* programme as in **Annexure: IV**.
